Contracts: Any contract which is made between you or your partner (or a firm or body corporate in which you or your partner is a partner or a director, or in the securities of which you or your partner has a beneficial interest) and the Borough Council —

(a) under which goods or services are to be provided or works are to be executed; and
(b) which has not been fully discharged.

"Director" includes a member of the committee of management of an industrial and provident society;

Land: Any beneficial interest in land which is within the area of the Borough Council which gives you or your partner a right to occupy the land or receive income.

Securities: Any beneficial interest in securities held by you or your partner of a body where—

(a) that body (to your knowledge) has a place of business or land in the area of the Borough Council; **and**

(b) either—

(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; **or**

(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest which exceeds one hundredth of the total issued share capital of that class.

“securities” means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
