- Subject Matter:** On 13 August Cabinet has approved Main Modifications to the Local Plan for public consultation, as requested by the Planning Inspector. The Main Modifications are a combination of those put forward in the letter from the Inspector received on the 16 May 2018 and those proposed by Rugby Council. All representations relating to the Main Modifications will be taken into account by the Inspector. An updated Habitats Regulation Assessment and Sustainability Appraisal are also being consulted on.
