Dear Pete

Thank you for the kind invite to the public meeting, unfortunately we are unable to attend. Investin Brandon Ltd is continuing to promote new development proposals for a high quality housing development at the Brandon Stadium site.

We are in the early stages of developing housing proposals on this sustainable brownfield site in the Green Belt. In doing so we are keen to work with the local community to progress a high quality scheme which will positively contribute to the area and increase the local housing choice. The proposal is being worked up in an area where there is an existing shortfall of housing.

A public exhibition was held on 18 October 2014 setting out the initial proposals for the site. The exhibition was well attended and a wide cross section of opinion was expressed including preferences from Speedway fans for the stadium to remain.

It will be a matter for the planning authority to reach a balanced judgement between the competing planning interests, weighing the advantages of the more efficient use of brownfield land and the need for more housing in the Rugby Borough against the loss of the stadium.


Dear Sirs,
